# 2<sup>nd</sup> Reading Ordinance 2023-09 – Variances

Tjaden moved to give second reading and adopt ordinance 2023-09 to amend the zoning ordinance to permit a variance for the fencing standards. E. Waltner seconded the motion. Roll call: All votes aye.

# AN ORDINANCE AMENDING SECTION 1509 (VARIANCES), NUMBER 1 (PURPOSE) OF "THE OFFICIAL ZONING ORDINANCE OF THE CITY OF FREEMAN", HUTCHINSON COUNTY, SOUTH DAKOTA, BY ADDING ANOTHER CATEGORY FOR VARIANCES.

Be it ordained by the City of Freeman, Hutchinson County, South Dakota, that Section 1509(1) of the Official Zoning Ordinances of the City of Freeman, is hereby amended to read as follows:

Section 1509 Variance

- 1. <u>Purpose</u> The Board of Adjustment may vary the regulation of this ordinance in harmony with its general purpose and intent, but only in specific instances where the Board makes a finding of fact based on the standards prescribed in **Section 1509(4)**. Variances may be granted:
  - A. To permit any yard of less dimension than those required by this ordinance;
  - B. To permit any building to exceed the floor space provided by the ordinance;
  - C. To permit the use of lot prohibited solely because of insufficient area of the lot;
  - D. To permit construction of a building or structure which will exceed the height limit for the district in which it is to be built;
  - E. To permit off-street parking which does not conform in quantity or other particulars with the requirements of this ordinance; and
  - F. To permit variations in the fencing standards set forth in **Section 1213(11)**.

All other numbered provisions contained in Section 1509 (numbers 2 – Application, 3 – Disposition by Board of Adjustment and 4 – Standards) shall remain as previously enacted.

Waltner also asked if some culverts could be cleaned by city street team; weather conditions are favorable and carrying out this process would lessen spring flooding risks. Saarie and Duane Walters will discuss plans regarding this request.

E. Waltner shared that the Freeman Community Foundation awarded grant funding requested by LeAnn Kaufman to replace the library's fluorescent lighting with LED lights.

Saarie reported on a recent meeting with Freeman Community Development Corporation representatives, confirming that the city has met the agreed upon financial responsibilities related to the Westward View Addition. Members of the council inquired about the removal of cement from a decommissioned well and trees in the vicinity of where the shed had been located on the property. Saarie will follow up in response to the questions raised.
